

ICCR Scholarship for studies in India for the Academic Year 2021-22

Applications are invited from Tanzanian students for government of India scholarships for pursuing Undergraduate, Post-graduate and doctoral courses in Indian Universities for the academic year starting in July 2021. Details are available at a2ascholarships.iccr.gov.in. Applicants may register and fill online application form and submit with all requisite documents. **The last date for submitting online application for Undergraduate and Postgraduate Courses is 30 April 2021.** In case of any questions, please write to: iccrtanz@gmail.com.

GUIDELINES FOR ICCR SCHOLARSHIP APPLICANTS

1. All applicants must register on the ICCR Scholarship portal a2ascholarships.iccr.gov.in fill the application form and submit it online alongwith all requisite documents. All relevant details are available on this ICCR portal.
2. Please read all the instructions carefully before filling out the forms. Please also read and understand the financial terms and conditions.
3. The scholarship includes return economy class air-fares to the nearest airport and 3rd AC Train fare to the place of study, if so required, apart from tuition fees paid to the institute and a monthly stipend. Please note that ICCR shall provide one way ticket to India at the beginning of the course and a return ticket to Tanzania after the course is completed. If the students need to visit Tanzania in between, the travel will be at the student's own cost.
4. Only students proficient in English may apply for admission since all teaching will be in English. For AY 2021-22, a 500 word essay in English has been introduced to ascertain English Proficiency. Besides, students can also submit their TOFEL/ IELTS etc. Standardize Test scores, if available.
5. Rejected Students will be intimidated by the Universities.
6. Only Students, who are above 18 year of age by July, 2021 are eligible for admission under the scholarship scheme and maximum age is 30 years. **Age limit for Ph. D students is 45 years**
7. Those who are suffering from life threatening illness or any other medical condition requiring long term treatment are not eligible to apply.
8. Applications will be accepted only through the portal.
9. The council does not offer scholarships for medical / paramedical /Nursing/ Physiotherapy / Anesthesia / Fashion courses.
10. Please note that for science courses, the expenditure on laboratory chemicals and other related incidental charges will be borne by the students themselves.

11. In order to ensure security of foreign students, ICCR advises students to stay in hostels, if available. However, students are allowed to stay in private accommodation if the concerned institute does not insist on staying in their hostel.
12. Please note that an application will be considered only after it is verified and recommended by the High Commission of India, Dar es Salaam.
13. Please note that your placement to a particular educational institution / University will depend on the availability of seats and the course that you are choosing. Therefore, before choosing your five choices, you are advised to check the Institutions/Universities available for the discipline that you intend to study. Those applying for post-graduate and doctoral courses should check specialization and eligibility requirement with greater care. You may like to see list of Institutions/ Universities where ICCR scholars are studying at present on the portal.
14. Personal medical insurance is a mandatory requirement for availing ICCR's scholarship. You must have medical insurance coverage on your own either before travel or immediately after reaching India, whatever is convenient to you. Students can purchase medical insurance from any of the insurance companies of their choice. However, to facilitate students, A2A Portal has two insurance companies for referral purpose.
