4. Suppliers are required to submit their bids in a sealed envelope describing in detail the specification of the requisite items. Since only some of the crucial specifications are listed above, it is emphasized that detailed technical specifications of the LED Screen may be submitted as this shall become basis for selection of the best option by the High Commission. The bids should be valid for a period of three months from the date of the opening of bids.

5. The sealed envelope (Title: PRICE QUOTATION FOR SUPPLY AND INSTALLATION OF LED DISPLAY PANEL IN HIGH COMMISSION OF INDIA) should be submitted to the attention of the Head of Chancery, High Commission of India, Dar es Salaam <u>latest by 1500 hrs on 20.07.2021.</u>

The payment shall be done subsequent to the delivery and installation of the equipment at the above cited location and the quoted prices should include the cost of hardware, software, and installation of the equipment. The successful bidder shall be obliged to deposit an amount equivalent to 5% of the value of the contract to be awarded as performance security. The performance security shall remain valid for a period of 60 days beyond the completion of all contractual obligations of the

bidder. The bid security shall be refunded to the successful bidder on the receipt of the performance security.

7. If any information furnished by the applicant is found incorrect at a later stage, the bidder shall be liable to be debarred from the tendering process. The High Commission of India reserves the right to verify the particulars furnished by the applicant independently.
