#### **SECTION-I**

## **Terms & Conditions** for Bidders:

- 1. Submission of Bids: Technical and Financial Bids should be prepared separately and submitted in two separate sealed envelopes, both of which should be further enclosed in a larger sealed envelope superscribed with the words "Supply and Installation of Power Backup System for ICR Resource Centre at NM-AIST, Arusha, Tanzania". The following documents shall form part of the bid:
  - Tender Document and addendum if any, duly signed by the bidder to abide by the terms and conditions of the tender document.
  - Bid Security Declaration
  - Valid Certificate of dealership attested by dealer with stamp
  - certificate of Bid validity
  - Certificate of warranty
  - Details of authorized service centre for providing warranty services
- **2. Bid Security Declaration:** The bidder will have to furnish a 'Bid Securing Declaration' along with their bid as per the format at **Annexure-II**. Any bid which is not accompanied with the 'Bid Securing Declaration', shall be rejected.
- 3. Clarification regarding contents of the Tender: A prospective bidder who requires clarification regarding the contents of the bidding documents shall notify to the High Commission of India in writing about the clarifications sought not later than 14 (fourteen) days prior to the date of opening of the Bids.
- 4. Modification and Withdrawal of Bids: A bidder may modify or withdraw his bid after submission provided that the written notice of modification or withdrawal is received by the High Commission of India prior to deadline prescribed for submission of bids. A scan copy of withdrawal notice may be sent by e-mail but it should be followed by an original signed confirmation copy of withdrawal notice to be sent by post and such signed confirmation should reach the High Commission of India not later than the deadline for submission of bids. No bid shall be modified after the deadline for submission of bids. No bid may be withdrawn in the interval between the deadline for submission of bids and expiration of the period of bid validity specified.
- **6**. **Validity of Bids:** The Bids should remain valid till <u>(180 (Days)</u> from the last date of submission of the Bids. A bid valid for a shorter period shall stand rejected.
- 7. No. of bids per Make/Model: Each bidder shall submit only one bid for a particular make/model of Batteries. A bidder who submits more than one bid for the same make/model shall be disqualified.
- **8. Cost of bidding:** The bidder shall bear all the costs associated with the preparation and submission of bid and the buyer shall not be responsible or liable for these costs.

- **9. Amendment of bidding document:** The High Commission of India, Dar-es-Salaam may amend the bidding document by issuing Addendum, before the deadline for submission of bids.
- **10.** Language: All documents relating to the bid shall be in English language. If any document is not in English, an courtesy English translation copy may be attached.
- 11. Eligibility of bidder: Only Authorised dealers/suppliers are eligible to participate in this tender. Further, the bidding companies should have minimum 3 years' experience of supply/ dealership of such power backup systems.
- **12. Price details to be specified in Bid:** The price shall be inclusive of all incidental charges including transportation, installation etc., as per the format attached at **Annexure-III**. <u>All rates shall be quoted only in Tanzanian Shillings (Tsh).</u>
- 13. Evaluation of all bids and announcement of successful bidder: The Technical bid will be opened on 23.02.2023 at 1530 hrs. at High Commission of India, Dar-es-Salaam. The Bidders may depute their representatives, duly authorized in writing, to attend the opening of Bids on the due date and time. This event will not be postponed due to non-presence of representatives of any bidder. After evaluation of the technical bids by the appointed committee of the High Commission of India, the Financial bids of the qualified bidder will be opened at a later date and time in the High Commission of India. The date and time will be intimated to the qualified bidder to send their representatives to attend the bid opening.
- **14. Evaluation Criteria:** The broad guidelines for evaluation of Bids will be as follows:
- **14.1** All the Technical Bids will be opened first. Bids that are not compliant with all the eligibility and qualifying requirements of the NIT will be discarded.
- 14.2 The financial bids of those bidders who pass the Technical Bid evaluation will be opened next. The successful bidder will be decided on the basis of the lowest price quoted, as per the Price Format specified in the tender document.

### **SECTION-II**

### Terms & Conditions after selection of successful bidder (henceforth 'Supplier')

- 1. Delivery Period: The Supplier shall be required to complete the work within 30 days from and including the date of the award of work. The period of delivery is not expendable. Buyer would be entitled to unilaterally cancel the Order in case items are not received within the stipulated delivery period. Extension of contracted delivery period will be at the sole discretion of the Buyer.
- **2. Warranty:** The Supplier shall provide warranty of batteries against manufacturing defects and free services for a period of two years. The Supplier shall have authorized service provider in Tanzania.
- **3. Performance Bank Guarantee (PBG):** The successful bidder shall submit within 30 days from receipt of supply order, a Performance Bank Guarantee (PBG) equivalent to 03% of the order value. The Bank Guarantee shall remain valid for 60 days beyond the date of completion of Warranty Period of 02 years.
- 4. Payment: The 100% of payment shall be released to the supplier after satisfactory and successful installation of power backup system on receipt of confrimatoiin from NM-AIST and the Indian Mission. The Payment will be made in Tsh by bank transfer in favor of the Supplier, after satisfactory completion of work by the High Commission of India after satisfactory completion of work. Bidders to quote the price of power backup system inclusive of all taxes/overheads and other expenses. No separate payment on account of other incidental charges or taxed shall be made by the Mission.
