1. This Invitation for bids follows the General Procurement Notice which appeared in the Daily News dated 30th July, 2018.
2. The Government of the United Republic of Tanzania has set aside funds for the operation of the National Food Reserve Agency (NFRA) during the financial year 2018/2019. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the Supply of Agrochemicals and Fumigants
3. The National Food Reserve Agency now invites sealed tender for carrying out the Supply of the following items:

Lot No.	Description of Item	Quantity
1	Permethrin 380EC	748 Litres
2	Dichlorovous 500EC	1900 Litres

The bidder must quote for one or both lot for all quantities specified in each lot. Bid for incomplete lot will be considered non-responsive and rejected.

4. Tendering will be conducted through National Competitive Tendering procedures specified in the Public Procurement Regulations (Amendment) GN 333, 2016 which reads as one with Public Procurement Regulations, 2013 as defined in the Regulations.
5. Interested eligible Tenderers may obtain further information from and inspect the tendering documents at the office of the **Secretary, National Food Reserve Agency Tender Board, Kizota, West Industrial Area, P. O. Box 1050, DODOMA** from 7:30am to 3:30 pm on Monday to Friday except on public holidays.
6. A complete set of Tendering Document(s) in English and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of Tshs 100,000 (**Tanzania Shillings One hundred thousand only**). Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to **Chief Executive Officer P.O. Box 1050, Dodoma**.
7. All tenders must be accompanied with a Tender Security in an acceptable form in the amount of 2.5% of the bid price.
8. All tenders in one original plus two copies, properly filled in, and enclosed in plain envelopes must be delivered to the address **The Secretary, National Food Reserve Agency Tender Board, Kizota, West Industrial Area, P. O. Box 1050, DODOMA** at or before 10:00am on **Thursday, 13th December, 2018**. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the **National Food Reserve Agency Head Office - Conference Room located at Kizota, West Industrial Area**.
9. Late tenders, portion of tenders, tenders not received, tenders not opened, and not readout in public at the tender open ceremony shall not be accepted for evaluation irrespective of the circumstances.
